- The front door closure is inoperable and we are waiting on a part to be installed
- We had the bed bug dog inspection and there is no activity
- The Asst. Library director from Belmar will be coming in to start helping tenants with technology use

Open Public Portion

Anita Percorelli of 103 Shark River Rd # 59:

- Tenants have asked for walk in tubs but have been told that they cannot have them
 - o Mr. DeSantis advised that this building is intended for self care residents and we are not able to adjust the tubs
- Would like to know where the \$100,000 hud grant is
 - o Mr. DeSantis advised that that is our capital fund money held by HUD
- Whose boat is on the property
 - o Mr. DeSantis advised it is the Superintendants
- Has there been any further reportable issues with the elevator
 - o Mr. DeSantis advised No
- Are there any bricks falling from the building
 - o Mr. DeSantis advised No
- Advised there is an affordable connectivity program available to the residents for \$30/ month for internet

Mary Manley:

- Why is the front door not working
 - o Mr. DeSanits advised that we are waiting on a part for it to be fixed
- It is fire season and there are cigarette butts all over the front patio and needs to be cleaned up

- Third floor light has been out
- Suggested we apply for funding to fix the building through philanthropist like Bon Jovi and Alicia Keys
- Advised that when the elevator stops it is not flush with the floor
 - o Mr. DeSantis advised that he would look into this as he has not noticed that when he rides the elevator

Councilwoman Rondinaro:

- Is there a deadline for receiving the quotes for the scaffolding
 - o Mr. DeSantis advised that he is waiting one more week
- Where did we apply for grant money for the elevator
 - o Mr. DeSantis advised through our insurance company
- Can we privately fundraise
 - o Mr. DeSantis advised that we will look into that and speak to our auditors and accountants
- Is there a way to retri fit the bathtubs as there is a big gap between here and long term care
 - o Mr. DeSantis advised that he will talk to the engineer
- In the future can we move the board members to the front of the table
 - o Mr. DeSantis advised that we will work on that.
