- Mrs. Farber also advised that she has lived in this building for over 20 years and that the elevator does not always work properly.
 - Mr. DeSantis advised that we need to have the bricks reattached to the building.

 - O She was advised that we have to wait for the budget to pass in order to have the funding to award the bid
- Asked who tenants can report personnel concerns to.
 - o Ellen Ramey is the tenant representative to the board so they can report it to her if they would like in writing and she can bring it to the board

Anita Percorelli of 103 Shark River Rd # 59:

- Asked when we receive our capital money
 - o Paul advised it is annually
- Asked for explanation on the 9% increase in rent
 - Advised that rents aren't increase 9%, we are just able to increase our anticipated revenues by 9% due to the social security increase that residents received last year.
- Asked about the timeline for funding from Chris Smith
 - O Advised that it will take time as it has to go before the House an Senate an may not possibly have results until January
- Advised that the elevator is an issue again as someone got stuck in it the other day

Sharon Mohoney

- Why do we not publish our meetings in The Coast Star each month
 - We publish our resolution at the beginning of the year that list all our meeting dates and it is also on our website
- Request a fix for the meetings so that residents can hear what the board is discussing
- Elevator should be priority
